KMA Guild Member Event at the Eugenia Williams House

On September 18th, the KMA Guild members visited the beautifully restored Eugenia Williams home on Lyons View Pike. The home has been stunningly restored in every original detail by the Aslan Foundation. It was a wonderful opportunity to tour the home and meet members of the Aslan Staff. Guild members took a break from the tour to enjoy a boxed lunch provided by The Plaid Apron. Afterwards, Jack Neely, founding Director of the Knoxville History Project, and longtime journalist and historian, was the featured speaker. As a native Knoxvillian, Jack remembered delivering newspapers on Lyons View and had passed the home numerous times, although Eugenia Williams was not one of his deliveries. The estate consists of 24 acres adjoining the Tennessee River and the architecture of the home is in the Regency Style. Furnishings are very beautifully detailed and styled according to the era when the home was completed in 1941. Every room features windows, creating an open atmosphere throughout the home. Ms. Williams, born in 1900, lived a long and interesting life, with a love of travel and fashion. However, she also experienced much sadness with the early deaths of her close family members. Her history and legacy of this beautifully restored property will endure for future generations to enjoy.

Board Transition Meeting










New KMA Guild Brochure

Christy Smith, Assistant Director of Development Knoxville Museum of Art

Meet Christy Smith. KMA's new Assistant Director of Development. At the end of April this year, she arrived at the Museum just in time for the Guild's plein air painting fundraiser – Artists On Location. Since then, Christy has embraced her new position with a creative energy, bringing to it a fresh approach and her own set of skills, talent and past experience.

Meeting for lunch in July at Chesapeake's Downtown, Christy and I sat down for a delightful one-on-one exchange over lunch, sharing some great seafood and discussing how our life paths had led us to KMA. Christy's story made me think of Steve Jobs' Stanford Commencement Address, wherein he spoke of "connecting the dots". He said, "You can't connect the dots looking forward; you can only connect them looking backwards. So you have to trust that the dots will somehow connect in your future. You have to trust in something – your gut, destiny, life, karma, whatever."

Starting her college career studying Journalism at The University of Georgia in Athens, Christy learned she wasn't at the right place which explains her transfer to Appalachian State University in Boone, North Carolina. There, she studied Modern European History, Aesthetics and Art History, and majored in Philosophy with a History minor. Next, a stint at the University of South Carolina's Law School taught her that she was not meant to have a career in law! However, while in Columbia working at a store selling vinyl records, she met her future husband Shane, whose music career would involve several moves, eventually leading the couple to settle in Knoxville in 2018.

After being involved in several community service organizations, such as Meals on Wheels, volunteering at the Knoxville Zoo, working as a store and district manager

for the non-profit Amvets Thrift Store, and as the Volunteer Manager at Ijams Nature Center, Christy set her sights on KMA. Frequent visits to the website led her to see an opening in the Development Department.

Christy said, "When I interviewed with Margo Clark, I knew the job was a right fit for me. I just felt like the Museum staff were 'my people'!"

The Guild is so lucky to have Christy working directly with us on our fundraising efforts. Her warm personality and her intelligent approach to managing projects will be invaluable to fundraising success. In addition to her involvement with AOL and Holiday Homes Tour, she is working with the Donor Software System, Tax Receipts, Exhibition Sponsorships, Grant Writing, Family Fun Day, and Art House. She is also helping our Executive Director Steven Maticjio with future music projects in the Museum.

It seems the dots have connected for our Christy Smith!
